GOLDEN WHEEL CERTIFICATE GENERAL TERMS AND CONDITIONS

LEGAL INFORMATION

GOLDEN WHEEL CERTIFICATE is a legal label/brand registered in the Trade and Industry Register (RCI) of MONACO under the n* 2200418, property of FIFTY CONSULTING :

ARTICLE 1. SUBJECT

conditions of payment and use of the GOLDEN WHEEL CERTIFICATE

abonnement program via its website www.goldenwheelcertificate.com (hereinafter referred to as the "Site") to any natural person of legal age who is a consumer (hereinafter referred to as the "Customer").

These GTC apply to the exclusion of all other conditions and in particular those applicable to sales in shops or by means of other distribution or marketing channels for the Products. All other documents, such as leaflets, emailing, catalogues or photographs of the Products are only indicative.

They are accessible at any time on the Site and shall prevail, if necessary, over any other version or any other contradictory document. They must be accepted by the Customer prior to the validation of any subscription.

Any sale of Products or abonnement by GOLDEN WHEEL CERTIFICATE to the Customer is therefore governed, without restriction or reservation, by these GTC. Consequently, the fact that the Customer subscribe an abonnement on the Site implies that the Customer accepts these GTC without reservation. By subscribing an abonnement on the Site, the Customer undertakes to be at least eighteen (18) years old and to have the legal capacity to enter into this contract on the date of the subscription, it being recalled that, in accordance with Article L. 3342-1 of the French Public Code and Ordinance No. 59-107 of 7 January 1959 and Law No. 74-631 of 5 July 1974, the sale or subscription of abonnements to minors and persons of equivalent age are prohibited.

ARTICLE 2. MODIFICATION

GOLDEN WHEEL CERTIFICATE reserves the right to modify these GTC at any time. The modifications of these GTC are enforceable against the Customers of the Website as of their publication on line and cannot be applied to transactions concluded previously. All orders placed are subject to the GTCs posted online on the day of the order.

GOLDEN WHEEL CERTIFICATES reserves the right to modify its abonnements at any time and can modify the logo and the name of its proposed label.

ARTICLE 3. SUBSCRIPTION TO ABONNEMENT

The abonnements offered for subscription are the ones which appear on the Site. The Customer is obliged to choose one of them before subscribing, the choice and subscription of an Abonnement being the sole responsibility of the Customer.

We only sell 2 types of abonnement : 1 monthly and 1 yearly.

GOLDEN WHEEL CERTIFICATE undertakes to supply the Abonnement subscribed by the Customer within the limits of ONE (1) WEEK.

ARTICLE 4. PRICES

The prices are expressed, for each of the abonnement listed on the Site or presented by email, in Euros, all taxes included.

The prices quoted are firm and non-revisable during their period of validity. GOLDEN WHEEL CERTIFICATE reserves the right to change its prices at any time. The price applicable to the Customer will be the price displayed on the Website on the day of the order and for a minimum of one (1). year. The price displayed on the Website takes into account any promotional operations implemented by GOLDEN WHEEL CERTIFICATE on the Website.

The prices can be changed at the subscription's yearly renewal anniversary. An e-mail with the new pricing will be sent to the Customers prior its application and the Customer will have the right to withdraw during this period of time.

ARTICLE 5. SUBSCRIBING

5.1 Subscribing process

Subscriptions can be placed by the Customer on the Site only AFTER submitting its candidacy to the GOLDEN WHEEL CERTIFICATE EXPERT TEAM and their APPROVAL, following the subscription process described below:

The Customer first submits its candidacy to the GOLDEN WHEEL CERTIFICATE EXPERT TEAM by filling in the application page the most accurately possible.

He/she certifies that he/she is of legal age to submit their candidacy, he/she reads the GTC and ticks the box "I have read and accept the GTC". The candidacy is registered when the customer has accepted the GTC by ticking this box.

If validated by the GOLDEN WHEEL CERTIFICATE EXPERT TEAM, the customer will receive an email where he will be able to choose his abonnement subscription preference.

The Customer then chooses his/her payment method and validates the

payment after verifying the information related to his/her abonnement.

Once the preference of abonnement is selected and the payment validated, the Customer will be invited to send by e-mail the pictures he is using online and on which he/she would like the GOLDEN WHEEL CERTIFICATE logo to be displayed.

Finally, GOLDEN WHEEL CERTIFICATE sends back the Customers pictures upgraded with its official logo to the e-mail address provided by the Customer.

During the subscription process, the Customer do not have access to its candidacy application and cannot view or correct any errors. The Customer alone is responsible for any errors made during the ordering process.

Any subscription placed, validated by the Client and confirmed by GOLDEN WHEEL CERTIFICATE under the terms and conditions described above, on the Website, constitutes the formation of a contract concluded at a distance between the Client and GOLDEN WHEEL CERTIFICATE. In the absence of proof to the contrary, the data recorded in GOLDEN WHEEL CERTIFICATE's computer system constitutes proof of all transactions concluded with the Client.

5.2 Terms and conditions of the subscription

By subscribing an abonnement, the Customer expressly accepts the prices, the descriptions of the abonnements and the GTC.

Subscriptions are validated as soon as possible by email. No subsequent modification is possible without the express agreement of GOLDEN WHEEL CERTIFICATE. By subscribing an abonnement on the Site, the Client expressly waives the benefit of Article 1587 of the French Civil Code.

GOLDEN WHEEL CERTIFICATE reserves the right to refuse or cancel an abonnement:

If the informations collected in the application form aren't accurate or are false, GOLDEN WHEEL CERTIFICATE can stop the abonnement any time.

The Customer will have one (1) week to remove the GOLDEN WHEEL CERTIFICATE logo from his online pictures and will not be able to reclaim any kind of refund.

5.3 Cancellation of an abonnement

In order to be taken into consideration, any request to cancel an abonnement must be made minimum one (1) month before its yearly renewal.

The request must specify the name of the Customer and its abonnement number.

Without any request in the requested time, the abonnement will automatically be renewed for a period of one (1) year.

ARTICLE 6. TERMS AND CONDITIONS OF PAYMENT OF THE SUBSCRIPTION

The price is payable in full on the day the Customer subscribes to the abonnement.

The Customer must make payment immediately upon subscribing by : Carte Bleue, Visa, Mastercard. The Customer will then be redirected to the payment interface of GOLDEN WHEEL CERTIFICATE's banking partner, which is 3D Secure. For any other payment method, the Client must contact GOLDEN WHEEL CERTIFICATE directly. Payments made by the Client shall only be considered final after the actual collection of the amounts due by GOLDEN WHEEL CERTIFICATE.

The Client guarantees GOLDEN WHEEL CERTIFICATE that he/she has the necessary authorisations to use the credit card used. An invoice shall be issued by GOLDEN WHEEL CERTIFICATE and given to the Client upon subscription of the abonnement

ARTICLE 7. LIABILITY

GOLDEN WHEEL CERTIFICATE guarantees that it will provide abonnements that comply with the regulations in force and with the characteristics advertised on the Site.

GOLDEN WHEEL CERTIFICATE shall not be held liable in case of incomplete or erroneous data entry by the Customer.

GOLDEN WHEEL CERTIFICATE can transfer at any time parts or all of its activity to another entity without having to address the change to its Customers.

ARTICLE 8. RIGHT OF WITHDRAWAL

In accordance with article L. 221-18 of the French Consumer Code, as a consumer, the Customer may exercise his/her right of withdrawal within fourteen (14) days of subscribing to the abonnement. The Customer does not have to give any reasons and will not be subject to any penalties.

To exercise this right of withdrawal, the Customer must notify his intention to withdraw, before the expiry of the withdrawal period, by means of an unambiguous statement via :

A letter containing his name, address and possibly his telephone number and e-mail address sent to the address (the postmark being proof of this): 15 rue Honoré Labande, FIFTY CONSULTING at PUZZLE CENTER, 98000 MONACO ;

An e-mail containing his name, address and possibly his telephone number and e-mail address sent to the address (the date of sending being taken as proof): contact@goldenwheelcertificate.com

In case of withdrawal by the customer on time, he/she will have one (1) month to remove the GOLDEN WHEEL CERTIFICATE logo form all his/her online pictures after the end of its yearly contract.

If the GOLDEN WHEEL CERTIFICATE logo is not removed on time after the withdrawal, a penalty of one (1) year subscription will be applied. The Customer will be able to keep the GOLDEN WHEEL CERTIFICATE logo on his/her pictures during this period of time.

ARTICLE 9. PERSONAL DATA

The Customer's personal data is collected and processed by GOLDEN WHEEL CERTIFICATE for the purpose of executing and managing subscriptions placed by the Customer on the Website.

In accordance with Law n°78-18 of 6 January 1978, known as the "Data Protection Act", as amended by Law n°2018-493 of 20 June 2018, and with Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data (RGPD), the Customer may at any time, in the context of their relationship with GOLDEN WHEEL CERTIFICATE, the right to access, rectify and delete their personal

data with GOLDEN WHEEL CERTIFICATE, the right to withdraw their consent, to request the portability of their personal data, to object to the processing of their personal data or to request the limitation of the processing and to define directives on the fate of their personal data after their death.

ARTICLE 10. COOKIES

The Website uses cookies. These are small text files stored on the Customer's hard drive, most of which are intended to enable or facilitate navigation and are necessary for the proper functioning of some of the Site's services.

The Customer may express his consent or oppose the use of cookies by setting his connection device appropriately.

The "Help" section of most browsers indicates how to proceed with the setting.

ARTICLE 11. INTELLECTUAL PROPERTY

All elements (database, graphics, texts, photographs, etc.) appearing on the Website are protected by intellectual property rights belonging to GOLDEN WHEEL CERTIFICATE.

No reproduction (other than for strictly private use) of any of the elements of the Website, nor any hypertext link to the Website, may be made without the express prior consent of GOLDEN WHEEL CERTIFICATE.

ARTICLE 12. APPLICABLE LAW

These GTC are subject to French law. In the event that any of the terms of the GTC are considered illegal or unenforceable by a court decision, the other provisions shall remain in force.

ARTICLE 13. SETTLEMENT OF DISPUTES

All disputes to which the purchase and sale operations concluded in application of these GTC could give rise concerning their validity, interpretation, execution, termination, consequences and consequences will be submitted to the competent courts under the conditions of common law. INFORMATION ON EXERCISING THE RIGHT OF WITHDRAWAL

You have the right to withdraw from your subscription without giving any reason within fourteen (14) days following the day on which you, or a third party other than the carrier and designated by you, takes possession of the label.

To exercise the right of withdrawal, you must notify us of your decision to withdraw from this contract by means of an unambiguous statement (e.g. letter sent by post, fax or e-mail). You may use the model withdrawal form but

this is not obligatory. For the withdrawal period to be respected, it is sufficient that you send your communication on the exercise of the right of withdrawal before the withdrawal period expires.

If you withdraw from your subscription, we shall refund all payments received from you, without undue delay and in any event no later than fourteen (14) days from the day on which we are informed of your decision to withdraw from your subscription. We will make the refund using the same method of payment that you used for the original transaction, unless you expressly agree to a different method; in any event, this refund will not incur any costs for you. Insert your name, geographical address and, where available, your telephone number, fax number and e-mail address. You can also fill in and submit the sample withdrawal form or other unambiguous statement on our website. If you use this option, we will send you an acknowledgement of receipt of the withdrawal by email without delay.
